Agricultural GHG Expert AgCert Joins California Climate Action Registry

MELBOURNE, Florida – AgCert Services USA Inc. has joined a key group of environmental leaders as a new member of the California Climate Action Registry (the Registry). As a participant in the Registry, AgCert will voluntarily measure and report its US greenhouse gas emissions, the main contributors to global warming. AgCert is a leader in the production and sale of agriculturally derived greenhouse gas (GHG) emission reductions.

AgCert's core business is generating GHG emission reductions from farm systems worldwide. The company works with farms to modify animal waste management practices in order to reduce emissions and supply its customers with Certified Emission Reductions (CERs). AgCert is qualifying its emission reductions as CERs under the Kyoto Protocol for use in the European Union's Emission Trading System and in other countries that are participants in the Kyoto Protocol.

AgCert's proprietary systems and processes include one of only two UN approved large scale methodologies for the production of offsets in the agricultural sector.

The Registry, created by California legislature in 2000, helps companies and organizations throughout the United States to track, publicly report and reduce their greenhouse gas emissions. The results are certified by independent organizations to ensure compliance with Registry protocols and standardization across sectors. Registry members can also establish GHG emissions baselines against which any future GHG emission reduction requirements may be applied. The Registry has been widely recognized as a gold standard for public reporting of greenhouse gases.

Todd Jones of AgCert said, "AgCert is looking forward to our partnership with California Climate Action Registry. We believe this is an important step as AgCert demonstrates our commitment to monitoring our GHG emissions and related offsets in the United States."

“There is growing concern in California about agriculture as a source of greenhouse gases” said Diane Wittenberg, President of the California Climate Action Registry. “We are excited to have a member like AgCert with such expertise in the agricultural field, for we are working to see how the agricultural community can measure and address its GHG emissions.”
