


# CARROT Version 2 Guidelines for PUP Reporters

# 1. PUP report


Complete the Excel PUP reporting spreadsheet, convert to PDF format, and upload into CARROT on the Emission Documents page in the Optional Reporting tab. Once certified, this report will be hyperlinked to your public report.

\*If you have created your new reporting year using the past year as a template, be sure to delete your PUP report from the previous year. There should only be one PUP report attached to your CARROT report.



#### 2. Metrics

Please report your Emissions Efficiency Metrics in the Entity Info section in the text box that asks "describe the primary emission factors and methodologies used in the calculation and tracking of GHG emissions" (see below).
