### **Purpose of the Workshop**

The Energy Commission, in conjunction with the Registry, will discuss the draft power generator / utility sector protocols. The public is invited to discuss the proposed industry-specific reporting and certification protocols. The Energy Commission staff and others will present a review of workshop questions, the key elements of the draft protocols, and receive public comment.

## Background

Senate Bill (SB) 527 (Stats. 2002, Ch. 769) requires the Registry to assist and enable participating entities to voluntarily record their annual greenhouse gas (GHG) emissions in a consistent and independently certifiable format. SB 527 also requires state agencies to provide technical guidance to the Registry in the development of GHG emissions reporting and certification protocols.
